Subject: Rationale for (3) Employee rate changes due to FLSA

The attached Exhibit A and B reflect revised expenditures to the 2016 Children and Youth Fund budget for the pay change for three employees.

In order to be compliant with the Fair Labor Standard Act (FLSA) that changes the minimum amount an employee has to make to not be considered for overtime pay to 47,476 effective December 1, 2016, this ordinance will adjust three employees pay rates to that amount. It will be more cost effective to raise the pay rate than to pay overtime for these positions.
