**DEFINITION OF CLASS:**

This is beginning-level technical work in the field of environmental protection. An employee in this class performs a variety of beginning level environmental protection work in specialized fields, such as food service sanitation, water pollution control, safe drinking water, solid waste, schools, bathing places, recreational areas, nuisances and hazardous materials. Assignments are selected to provide experience and training in the practical application of the principles of environmental protection. Initially work involves tasks of limited scope, but as technical proficiency is acquired, increasingly difficult duties are assigned. The employee's freedom to act is limited to fulfilling well-defined assignments. Supervision is received from higher level specialists who provide detailed instructions and guidance on new work; however, employees are expected to exercise independent judgment in carrying out assignments as experience is gained. Work is reviewed by higher level specialists and supervisors.

**DUTIES AND RESPONSIBILITIES:**

Conducts inspections of streams, water and waste treatment facilities, recreational areas, bathing places, mobile home parks, pollution complaints, food service facilities, municipal waste facilities and nuisances; reviews supporting data for rule, regulation or permit compliance; drafts technical reports with recommendations. Participates in vector surveys and prepares reports. Responds to hazardous materials incidents. Performs related work as required.

The above statements reflect the general details considered necessary to describe the principal functions of the job and shall not be considered as a detailed description of all the work requirements that may be inherent in the job

**KNOWLEDGE, SKILLS and ABILITIES:**

Knowledge of the basic principles of chemistry, bacteriology, biology, physics and mathematics. Some knowledge of the basic methods and techniques used in gathering and analyzing data. Skill in the use of inductive and

deductive reasoning. Ability to learn and recognize hazardous environmental conditions. Ability to express ideas clearly and concisely in oral, written and graphic form. Ability to secure and analyze facts and to conduct inspections of hazardous environmental conditions. Ability to establish and maintain effective working relationships with associates; government, professional and nonprofessional groups; and the public. Sufficient physical stamina to conduct field investigations in rough terrain and/or under adverse environmental conditions and the availability to travel out of Erie County as required by the agency.

**MINIMUM EXPERIENCE AND TRAINING:**

A Bachelor's degree with major course work in a biological or physical science, chemistry or in a field closely related to environmental protection.

**NECESSARY SPECIAL REQUIREMENT:**

Possession of a valid automobile operator's license.

**CONDITION OF EMPLOYMENT**

The selected candidate will be **pre-employment required** to obtain, at their own expense, 3 forms of clearance, including PA State Police Criminal History Record Check; PA Child Abuse History; and FBI Criminal History Background Check including finger printing. **This pre-employment requirement applies to all County employees exercising their bumping/bidding rights.**
