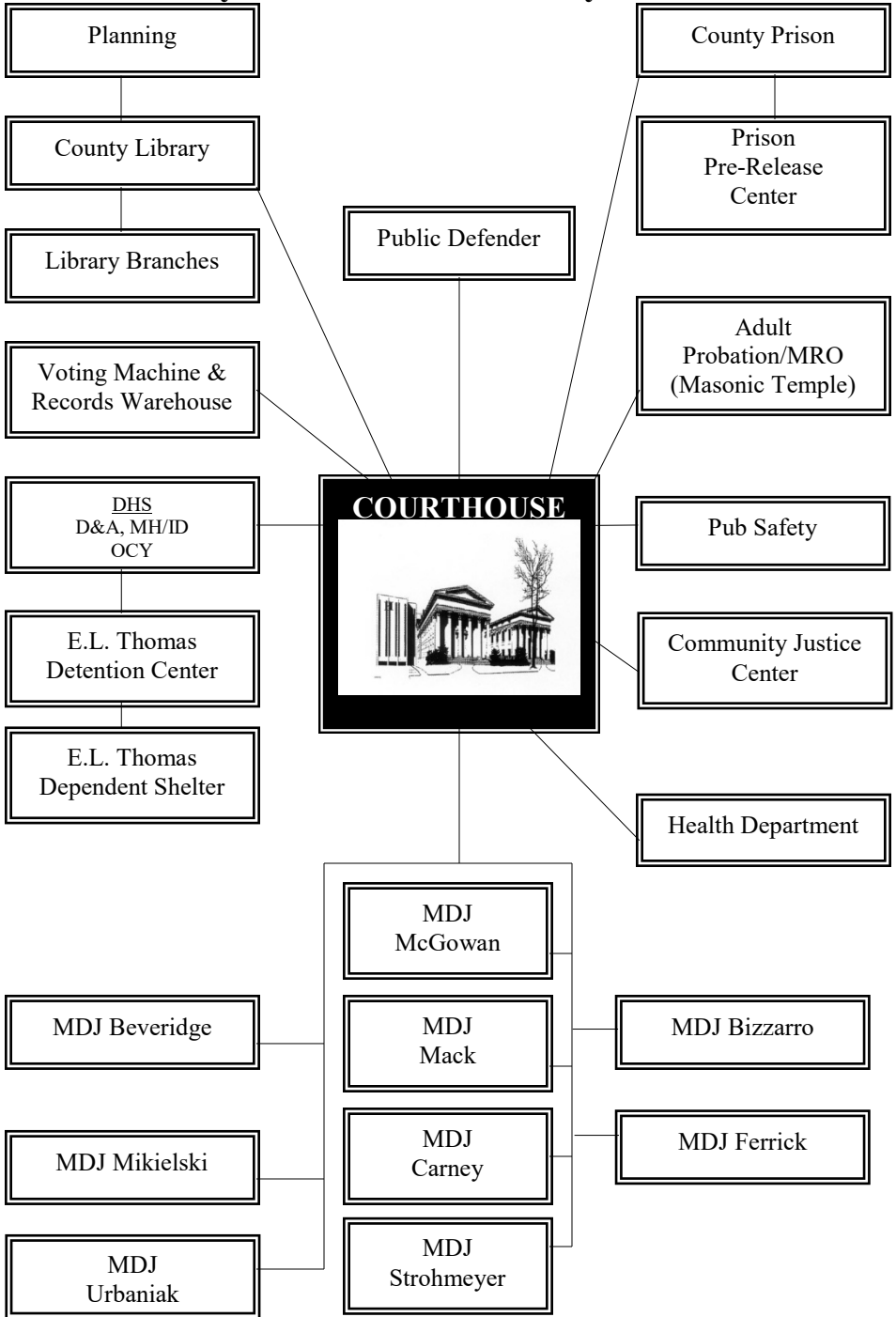

Telephone Instructions

TO CALL AN INSIDE NETWORK STATION:

Dial the 4-digit extension number within the network: Courthouse, Public Defender, Prison, Community Corrections Center, Health, Public Safety (EMA/E-911/Hazmat), Children's Services, Human Services, Voter Machine Warehouse, Adult Probation MRO, Juvenile Detention Center, Dependent Shelter, Drug and Alcohol, Library, Library Branches, Planning, Juvenile Probation Community Justice Center (see network diagram inside front cover.)

OUTGOING CALLS (LOCAL): - Listen for dial tone

- Dial the digit "9"
- Listen for the second dial tone
- Dial the local seven-digit number

LONG DISTANCE CALLING:

All long distance calls need your assigned long-distance code. Dial 9 – 1 – area code – seven-digit-number – long distance code. On long distance calls, do not let it ring more than six (6) times. After the sixth ring, the system will charge you whether you were connected or not.

PAGING: at Courthouse

- Dial the digits "**51 9**" Courthouse all floors (wait at least 5 seconds before speaking)

"51 3" Courthouse 3rd floor only (wait 5 seconds before speaking)

"51 4" Courthouse 4th floor only (wait 5 seconds before speaking)

at Children's Services

- Dial the digits "500"

at Health Department

- Dial the digits "50"

At the Court House, after the tone, pause for at least 10 seconds, then speak directly into the telephone receiver. Hang up gently.

++ If you hear a busy signal, hang up and try again.

INFORMATION OPERATOR:

for information, dial 9 – 1 – area-code – 555-1212 – long distance code or 411. There is a **charge** for information calls.

INTERNATIONAL CALLS:

Ask Operations, or Kara Lang (6328).

TELEPHONE REPAIRS:

If the telephone is not working properly, notify Kara Lang, Operations, ext. 6328 (451-6328) or klang@eriecountypa.gov. Arrangements for repairs will be made.

TELEPHONE CHANGES/ADDITIONS/DELETIONS:

Follow the same procedure as for repairs (above). When moving from one desk to another, generally your phone and extension number move with you. It is a very simple procedure and taking your programmed phone and extension with you BENEFITS YOU and keeps the Directory up-to-date.

WATTS (INCOMING within the 814 area code):

1-800-352-0026 (can be transferred to other buildings within the “network.” You may want to consider placing this number on your letterhead for calling within 814 area codes with your extension listed after it.)

OTHER SYSTEM FEATURES

VOICEMAIL INFORMATION:

To access a voicemail box dial **7060** or from outside the network dial **451-7060, #**. Delete message **76**; forward message **73**; send forwarded message **79**; blocking messages **80**; exiting voicemail **83** to hang up. Messages will store for **14 days**. Please delete messages as you listen to them.

LEAVE A MESSAGE DIRECTLY TO AN ESTABLISHED VOICEMAIL BOX:

In network dial **7004** or from outside the network dial **451-7004**.

TRANSFER CALLS DIRECTLY TO AN ESTABLISHED VOICEMAIL BOX:

If a caller requests to be transferred directly to an employee’s established voice mail box:

1. Press the **TRANSFER** button
2. Dial **7004**
3. Voicemail will ask for the intended extension follow with # sign; therefore, dial the extension of the employee and end with # sign
4. Press the **TRANSFER** button again on analog phone or press the **CONNECT** button on a digital phone and hang up.

TRANSFER CALLS TO ANOTHER EXTENSION:

1. Ask the outside party to wait while you transfer the call
 2. Depress **TRANSFER** (or **FLASH**) button
 3. Dial the extension that is to receive the call.
 4. When it starts ringing, you may hang up.
- ++ If the line is busy or no answer, from an **analog phone**, push **TRANSFER** (or **FLASH**) again to regain the original party. From a **digital phone** if the line is busy or no answer, push the key where the original party called in on.

CONFERENCE CALL: (Up to Six Parties)

To add up to six people to a call on a **Digital multi-line phone**

1. Press **CONFERENCE** key while on a call
2. Dial number of person to be added to conference (If busy, no answer or wrong number, press Goodbye key and then press flashing line key of original call)
3. Press **CONNECT** key to complete conference

To add up to six people to a call on an **analog phone**

1. Press **TRANSFER** key while on a call
2. Dial number of person to be added to conference
3. Press **TRANSFER** key again to complete conference

CALL BACK: (not used for outside calls, only internal calls)

1. Dial extension, if busy
2. Push **CALL BACK** button or **FLASH*2**
3. Hang Up
4. System will call you back when line is free.

PICK-UP: (To answer someone else's ringing telephone in your pick-up group) When you hear someone's telephone ringing in your pick-up group, pick up the receiver (getting a dial tone first) and then push the **PICK-UP** button or dial *** 8**.

CALL PICK-UP NOT IN GROUP or CALL PICK-UP DIRECTED:

If more than one phone is ringing in your area, you can dial **# 8 plus the ringing extension number** of the phone you want to pick up, and leave the other phones ringing.

CALL HOLD:

To place a call on hold, depress **HOLD** button and hang up.

To take a call off hold, depress **HOLD** button

NOTE: This hold will not allow new calls to come through to your telephone or allow you to make calls. Use **CALL PARK HOLD** to allow you to have use of your phone while holding another party.

CALL PARK HOLD:

This allows you to place the call on hold so you can receive or make new calls. It also allows you to pick up your held call at a different location if desired.

NOTE: You may want to program two speed dial buttons – one to Park Hold your call and one to retrieve your Park Hold call.

To Hold:

1. Make a connection.
2. Press **Flash * 9**.
3. Hang up.

To Return at Same Phone

1. Pick up receiver.
2. Dial **# 9**.

To Return Call At Different Location:

1. Pick up receiver.
2. Dial **## plus the extension where you originally dialed in FLASH * 9**

REDIAL:

The last telephone number dialed is automatically stored in **REDIAL**.

With a single keystroke you can redial that number:

1. Pick up the receiver.
2. Press the **REDIAL** button.

TO PROGRAM YOUR SPEED DIALS:

Refer to your telephone manual for programming instructions. If you are not clear on how to reprogram your “Speed Dial,” call Kara Lang, Operations, extension 6328 for assistance.

CALL FORWARDING – ALL CALLS:

To Forward ALL of Your Calls to Another Phone

1. Pick up receiver.
2. Dial * 4 plus the extension number where you want your calls to go.

To Cancel

1. Pick up receiver.
2. Dial # 4

CALL FORWARDING – WHEN BUSY:

This feature is programmed through the PBX. Call Kara Lang, Operations, extension 6328 for assistance.

CALL FORWARDING – NO ANSWER:

This feature is programmed through the PBX. Call Kara Lang, Operations, extension 6328 for assistance

TO SKIP LISTENING TO AN EMPLOYEE’S GREETING ON VOICEMAIL:

Press the number 5 during the greeting and then leave your message.

EMERGENCY CALLS:

Within the “network” (listed on the inside cover of this book) call 9-911 or just 911 and tell the dispatcher your location.

Do not put phones on HOLD (as a do not disturb) when leaving your office. Forward your calls to your destination or to another employee until you return. Putting a phone on hold ties up the trunk line so others cannot obtain an outside line.

ERIE COUNTY COURTHOUSE RECYCLING GUIDELINES:

All varieties of paper may be recycled in the office paper bin except carbon paper, napkins, tissues, plastic bags and food wrappers. Each **Friday**, the following items will be picked up in the hall outside of the office (please keep the following items separated): paper, newspaper, corrugated cardboard, magazines (high gloss). Continue to recycle your plastic bottles, aluminum cans, bi-metal cans, and garbage in bins that are provided in the hall locations. If you have any questions regarding the recycling program, please call extension 6019.

Used **toner cartridges** are collected in Room 05 at the Court House for recycling. Place your used cartridge in a box or bag before delivering it to Room 05 (Stock/Mailroom).

For recycling of old computer equipment:

1. Make sure it is off your department's asset inventory list.
2. Call Planning at ext. 6019 to inform them of the equipment.
3. Drop off at Court House outside of Rm 09 (Courts Computer Bureau). If there is a large amount call ext. 6219.
County recycling staff will recycle it from that point.
